CONDITIONS OF THE APPLICATION

By making an application to Transport a High Load, the Applicant agrees:

- That any consent issued by Top Energy Ltd is valid for the date and times specified on the consent
- That if the information provided is incorrect and as a result damage is suffered, the Applicant shall cover all costs of repairing that damage and indemnify Top Energy against any claims by third parties arising from that damage.
- To take all due care, whether or not the load is escorted
- That the issue of a consent by Top Energy does not exempt the Applicant from liability from damage to Top Energy's network caused by the load, whether it is escorted or not.
- A \$50 application and processing fee will be charged for applications where the load height exceeds 5.0m
- To abide by the terms of the consent and the directions of Top Energy's escort (if any), and
- To pay all charges required by Top Energy or Top Energy's Approved Contractors in connection with the transport or escort of this load, by the 20th of the following month.
- It is a Top Energy health and safety requirement that staff undertaking any work between 0200 hours and 0430 hours of more than four hours in duration between 2200 hours and 0730 hours, is required to have a stand down period of up to nine hours. Costs incurred as a result of this safety requirement for escorts of loads at or over 5.4 metres will be on-charged to the Applicant and are additional to any charges for the load escort itself.
- Any escort costs for load heights at or over 5.4 metres will be charged to the Applicant.
- Failure to pay all charges relating to this application may result in future applications being declined.
